"A RESOLUTION APPROVING AND ADOPTING THE MONITORING CHECKLIST AS A TOOL FOR MONITORING THE MEMORANDUM OF AGREEMENT AND IP ROYALTY, AGREED UPON DURING THE CONDUCT OF FPIC PROCESS"
